Parks and Rec Agenda Addendum:

To Robert Slayton, From Donna Ruiz on 8/25:

At the last meeting I said I would dig out the documentation we put together for priorities on drinking fountains (and benches/tables). Below is from P&R meeting earlier in the year:

From 2021 priorities:

Replace 1 picnic table and 1 bench at Chuck Roberts Park (specifically behind the bathroom and the picnic bench in play area)

1st Tier Priorities (not prioritized within this category)

Chuck Roberts: replace the **drinking fountain** in poor condition in addition to the new dual drinking station at Chuck Roberts in the 2022 plan. North side of basketball court: replace old, worn wooden bench facing the police station with a new bench. Assuming the plans to replace the old bench by the play structure and the old picnic table proceed as planned for 2022.

Skate Park/Old Town: **replace two broken drinking fountains with one fountain.** Staff to advise on placement, potentially further from the Skate Park entrance gate, to prevent damage. Perhaps surround the drinking fountain with bollards? Staff input valued and advised.

Creekside (new build): 1 picnic table and 2 benches; **new water fountain.**

1. Goals attached.
2. Park-specific projects are in the image below. The projects with numbers in the “expenditures 2022-23” column are the projects we expect to accomplish this year. I am unsure if signs for Creekside or Chuck Roberts fell under the 70A Misc. Parks Improvements for this year, or if that is reserved just for benches, tables, and drinking fountains – that is great question for Rob or Bret during the commission meeting.

A quick note:

- a. **There is also \$2,550 available in the Parks Commission fund.** If the commission wanted, some or all that money, could be used for signs.
- b. **There is also the ~\$4,500 Community Foundation Grant for the bronze rubbings.** Since those rubbings are a part of the signage/education/use from our parks, it could be a good way to also create the historical signage for Chuck Roberts and Lyn Newbry.
3. Yes - we have \$10,000 budgeted for landscaping at Kameron Springs under our Capital Projects.
