



## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Talent County Planning Commission will hold a public hearing on **Thursday, June 25, 2015 at 6:30 p.m.** in the Community Center located at 206 East Main Street, Talent, Oregon. The purpose of the public hearing is for the:

*Consideration of a Site Plan Review allowing the operation of a vacation/short-term rental home, located at 530 Tulipan Way, Talent, Oregon and legally described as Township 38 South, Range 1 West, Section 25CA Tax Lot 401. **File: SPR 2015-004.** This is a Type-2 land use application, which the Planning Commission approves or denies based on the criteria in Sections 8-3C.4, and 8-3L.1 of the Talent Zoning Ordinance. Appeals are subject to review by the hearings officer. The property is zoned RM-22 (Multiple Family - High Density). Applicant: Jeanne Sexton.*

Oregon law and Section 8-3M.150(C)(2) of the Talent Development Regulations (Title 8 of the General Ordinances of the City of Talent) state that testimony, arguments and evidence must be directed toward the approval criteria (attached), or other criteria in the Regulations that the person believes apply to the application. Failure to raise an issue at the hearing, in person, or by letter, or failure to provide sufficient specificity to afford the hearing body an opportunity to respond to the issue precludes an appeal to the Land Use Board of Appeals based on that issue. A copy of the rules (8-3M.150(D)) governing conduct of the hearing and submission of evidence and testimony at the hearing may be inspected at the Community Development Department at no cost during department business hours prior to the hearing, and can be provided at minimal cost.
