

## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Talent Planning Commission will hold a public hearing on <u>Tuesday</u>, <u>January 8</u>, <u>2019 at 6:30 p.m.</u> in Town Hall located at 206 East Main Street, Talent, Oregon. The purpose of the public hearing is for the:

Consideration of a Conditional Use Permit allowing the operation of a brewery and tasting room located at 59 Talent Avenue and described as Township 38 South, Range 1 West, Section 23DC, Tax Lot 902. File: CUP 2018-001. Decisions are based on the approval criteria found in Zoning Ordinance 8-3D.2 and 8-3L.2. Applicant: Kimber Parris & David Bartman.

Oregon law and Section 8-3M.150(C)(2) of the Talent Development Regulations (Title 8 of the General Ordinances of the City of Talent) state that testimony, arguments and evidence must be directed toward the approval criteria (attached), or other criteria in the Regulations that the person believes apply to the application. Failure to raise an issue at the hearing, in person, or by letter, or failure to provide sufficient specificity to afford the hearing body an opportunity to respond to the issue precludes an appeal to the Land Use Board of Appeals based on that issue. A copy of the rules (8-3M.150(D)) governing conduct of the hearing and submission of evidence and testimony at the hearing may be inspected at the Community Development Department at no cost during department business hours prior to the hearing, and can be provided at minimal cost. A SIGN UP SHEET WILL BE PROVIDED AT THE HEARING AND WHEN YOUR NAME IS CALLED YOU MAY GIVE YOUR ORAL TESTIMONY. ORAL TESTIMONY ON THIS HEARING SHALL BE LIMITED TO FIVE MINUTES PER PERSON. ADDITIONAL TESTIMONY (BEYOND THE FIVE MINUTE LIMIT) MAY BE SUBMITTED IN WRITING.

NOTICE TO MORTGAGE, LIENHOLDER, VENDOR, OR SELLER: THE TALENT CITY CODE REQUIRES THAT IF YOU RECEIVE THIS NOTICE IT MUST BE PROMPTLY FORWARDED TO THE PURCHASER.
