

## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City of Talent Planning Commission will hold a public hearing on <u>Tuesday</u>, <u>December 3, 2019 at 6:30 p.m.</u> (rescheduled from 11/26/19 due to inclement weather) in the Talent Town Hall located at 206 East Main Street, Talent, Oregon. The purpose of the public hearing is for the:

Consideration of Text Amendments to the Talent Zoning Code amending Title 18, Section 18.15, Section 18.20, Section 18.25, Section 18.30, Section 18.35, Section 18.40, Section 18.45, Section 18.50, Section 18.90, Section 18.95, Section 18.105, Section 18.110, Section 18.150, Section 18.180 and Section 18.190 and adding Section 18.96 Multi-Family Design Standards and Section 18.162 Cluster Housing. File: DCA 2019-001. Consideration of Text Amendments to the Talent Subdivision Code adding Title 17, Section 17.10.065 Emergency Access and amending Section 17.15 Application Requirements and Approval Criteria, Section 17.20.010 Final Plat Submission Requirements and Approval Criteria and Section 17.30.030 Flag Lot Partitions. Oregon law and the Talent Zoning Code provide the procedures for City sponsored legislative actions. Testimony, arguments, and evidence must be directed toward the approval criteria, or other criteria in the Ordinance which the person believes apply to the application. Failure to raise an issue at the hearing, in person or by letter, or failure to provide sufficient specificity to afford the hearing body an opportunity to respond to the issue precludes an appeal to the Land Use Board of Appeals (LUBA) based on that issue. A copy of the rules governing conduct of the hearing and submission of evidence and testimony at the hearing may be inspected at the Community Development Department at no cost any time prior to the hearing and can be provided at reasonable cost.

A SIGN-UP SHEET WILL BE PROVIDED AT THE HEARING AND WHEN YOUR NAME IS CALLED YOU MAY GIVE YOUR ORAL TESTIMONY. ORAL TESTIMONY ON THIS HEARING SHALL BE LIMITED TO FIVE MINUTES PER PERSON. ADDITIONAL TESTIMONY (BEYOND THE FIVE-MINUTE LIMIT) MAY BE SUBMITTED IN WRITING.

NOTICE TO MORTGAGE, LIENHOLDER, VENDOR, OR SELLER: THE TALENT CITY CODE REQUIRES THAT IF YOU RECEIVE THIS NOTICE IT MUST BE PROMPTLY FORWARDED TO THE PURCHASER.

A copy of the proposed amendments, all documents and evidence relied upon for the amendments and applicable criteria is available for inspection at no cost and will be provided at reasonable cost, if requested. A copy of the record will be available for inspection seven days prior to the hearing. Failure to specify which ordinance criteria an objection is based on precludes your right of appeal to LUBA on that criterion.
