

## NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Talent Planning Commission will hold a public hearing on **Thursday, May 25, 2017 at 6:30 p.m.** in Town Hall located at 206 East Main Street, Talent, Oregon. The purpose of the public hearing is for the:

Consideration of a Site Development Plan allowing the construction of an apartment complex located near the intersection of Suncrest Rd. and Highway 99 (address not yet assigned). and described as Township 38 South, Range 1 West, Section 23B, Tax Lots 1801, 1802 & 1803. The application also requests the consideration of a Variance to parking standards. File: SPR 2017-002 and VAR 2017-001. Decisions are based on the approval criteria found in Zoning Ordinance 8-3C.4, 8-3L.1 and 8-3L.4.

## **Applicant: Glenn Berk**

Oregon law and Section 8-3M.150(C)(2) of the Talent Development Regulations (Title 8 of the General Ordinances of the City of Talent) state that testimony, arguments and evidence must be directed toward the approval criteria (attached), or other criteria in the Regulations that the person believes apply to the application. Failure to raise an issue at the hearing, in person, or by letter, or failure to provide sufficient specificity to afford the hearing body an opportunity to respond to the issue precludes an appeal to the Land Use Board of Appeals based on that issue. A SIGN UP SHEET WILL BE PROVIDED AT THE HEARING AND WHEN YOUR NAME IS CALLED YOU MAY GIVE YOUR ORAL TESTIMONY. ORAL TESTIMONY ON THIS HEARING SHALL BE LIMITED TO FIVE MINUTES PER PERSON. ADDITIONAL TESTIMONY (BEYOND THE FIVE MINUTE LIMIT) MAY BE SUBMITTED IN WRITING.

NOTICE TO MORTGAGE, LIENHOLDER, VENDOR, OR SELLER: THE TALENT CITY CODE REQUIRES THAT IF YOU RECEIVE THIS NOTICE IT MUST BE PROMPTLY FORWARDED TO THE PURCHASER.
